Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

Because of the required prioritization of chronically homeless households for this rapid rehousing grant, there were difficulties because clients had fewer skills and were more difficult to engage than homeless clients who would be more appropriate for H-PASS RRH -- individuals with fewer challenges and lengthier job histories. Additionally, as a short-term housing program, landlords have been more hesitant to rent to rapid rehousing clients because there is built-in turnover. Landlords are more likely to accept clients for permanent housing because turnover is low for these slots. Rapid re-housing does not have this advantage so that there are longer lengths of vacancies. In addition, we cannot take on additional clients because case managers' caseloads are at peak capacity.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

H-PASS RRH 2019-2020 is a permanent rapid rehousing program that aims to serve 27 households (35 individuals) annually. Our initial population is the chronically homeless with lower VI-SPDAT scores; however, as this subgroup is relatively small, we are working with the Greater Hartford CAN to best identify and prioritize appropriate homeless candidates for this RRH intervention. As with all CRT Supportive Housing programs, H-PASS RRH complies with Housing First tenets and utilizes HMIS to monitor program progress. Clients will not be terminated for the reasons cited in 3c. Services will include a) outreach and engagement; b) housing search and placement counseling (i.e., temporary financial assistance and tenant counseling); c) mediation and outreach to landlords; d) case management services and service coordination in such areas as behavioral health, primary care, education, financial literacy, employment training, etc. e) referrals to legal services to assist households retain housing; f) housing inspections; and g) housing stability plans/supports. Households will typically receive some housing assistance support, such as rent and utilities. Most clients will stay for 6-9 months but a proportion will be able to be re-housed sooner and some may need to stay for up to 12 months. Many services prior and after housing can be provided by CRT, including intensive case management, behavioral health services, early care and education, financial literacy, etc. These and other services may be assumed by such external providers as DMHAS Capitol Region, Chrysalis, area shelters, Interval House, educational providers, etc. In terms of outcome measures: 90% of households will exit to permanent housing destinations during the operating year; 10% will be placed in permanent housing within 30 days of program entry; and 85% of adults will increase total income. On the last outcome, there is one caveat concerning young adult participants (18-24). CRT often works with this age group to enter education and/or training programs. Such activities can reduce the time spent on paid employment and this can skew the percentage of clients increasing income south. This program could not function or continue housing participants without COC funding.
