3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

LCS's Rapid Rehousing Program serves a significant need in New Haven. The Rapid Rehousing program adopts a Housing First model. The Region and State goal is based upon maintaining zero chronic homelessness. This program is an essential part of the CoC strategy to end homelessness through a combination of affordable housing and case management services targeted to those in the community who are homeless and have service needs. This program relies on the CoC for guidelines and evaluation to deliver the best program possible. LCS is requesting renewal fun for RRH for 10 single adults. Prioritization includes sheltered and unsheltered individuals, VI SPDAT score ranging from 4-7, and utilizing the 2-1-1 n scheduled CAN assessment and intake for selection and screening. The CAN is administered through the local United Way to facilitate coordinated assessment, housing readiness (documentation) and housing match. An inter-agency bi-weekly housing case conference has been in operation since July 2014.

The target population are single men and women with high housing challenges with a focus on individuals experiencing domestic violence, substance abuse, mental illness and HIV/AIDS. This project uses a progressive engagement approach and provides the smallest amount of assistance needed to end homelessness per household; thereby, the RA budget includes fewer units than the # of HH served PIT. The RRH program serves 10 households at a full point-in-time capacity in scattered site units in New Haven. All participants have leases in their own name and informed of their Tenant's Rights. Individuals will be seen

monthly, but as often as needed. Projected program outcomes include 86% of the clients will remain permanently housed at discharge, 86% of clients will be placed in permanent housing within 30 days of program entry, and 73% will maintain or increase total income by project exit. The project participates in HMIS and uploads data to the COC when necessary. Services include referral to primary health care, substance abuse treatment, mental health services and assistance with securing documentation for housing eligibility, and accessing mainstream resources such as SNAP, Medicaid and SSI/SSDI. The housing case manager provides or arranges transportation, housing search assessment of service needs and life skills, is an essential part of the treatment team making communication seamless. LCS participates actively in operations, entry and exit committees and the RRH sub-committee

of the CAN and has several staff members who conduct intake assessments on a daily basis for people screened through 211. LCS has several productive collaborative relationships with community providers. We are the subcontractor of the Yale Program on AIDS with 2 SAMHSA grants and twice a month, the Community Health Van parks at Safe Haven to provide access to primary health care free of charge.
