Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

This underspending primarily occurred because of the high barrier clients (no income at all, eviction rental history, criminal background) referred to the RRH Program by the Coordinated Access Network. This coupled with the understaffing of the RRH Program, caused the inability to house enough clients and spend the Rental Assistance budgeted. Our substantial amendment (moving funds from Rental Assistance to Support services) was approved allowing us to increase staffing and point in time households served.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Bristol and the Central Connecticut Coordinated Access Network (CCCAN) lacks adequate exit from homelessness housing placements for its non-chronic and chronic homeless population. Without The Balance of State Continuum of Care/ HUD funding for rental assistance and support services, Bristol and the CCCAN would have very few resources to move the chronic and non-chronic homeless people into permanent housing. The St. Vincent DePaul Mission of Bristol, Inc. Rapid Rehousing (SVDP RRH) program will provide tenant based rental assistance, housing find and supportive services to fourteen (14) single literally homeless individuals and eight (8) literally homeless families at a single point in time who reside at the Bristol Homeless Shelter and other shelters in the CCCAN. The goal is for a 30 day or less shelter stay. Participants will quickly access 1 bedroom, 2 bedroom and 4 bedroom apartments in the greater Bristol and New Britain area. RRH rental assistance will be provided according to Continuum of Care (COC) standards, which mandate a low barrier housing first approach. Community Health Resources (CHR) staff will assess participant service needs, provide case-management, insure mainstream resource acquisition and refer participants to local agencies and coordinate life skills training, employment, and mental health and addiction services. CHR staff will develop tenancy skills with participants and provide housing search assistance to locate affordable units as soon as possible. The Central Connecticut Coordinated Access Network (CCCAN) will refer clients to the Bristol Homeless Shelter and the SVDP RRH program simultaneously. All client data will be recorded in the statewide HMIS system. Projected outcomes are for 86% housing retention after program discharge, and 54% increase in household total income from entry to exit.
