Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

This grant was under spent by \$8,390. This amount represents under-spending in the supportive services portion of the budget due reduced staffing and rental assistance costs during the first several months of the first year of the project. During this period, it was necessary to hire and train staff. As a result the staffing costs were reduced and clients could not yet be matched to housing options, reducing rental assistance.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

HMIS data for 2017 documents that within the Greater New Haven CAN, 27 young adults were accepted for enrollment, while 96 were added to the wait list. The 2018 Homeless Youth Count estimated 816 homeless/unstably housed youth (under 25) heads of household in this CAN Region.

This RRH Project will serve literally homeless youth and young adults, singles and families, where the HH is between ages 18-24, at admission. All clients served will meet HUD and BOS requirements for eligibility. 100% of referrals will be from the local Coordinated Access Network. At any point in time, the project will serve 4 HH, typically comprised of 2 single and 2 families, where the HH is from ages 18-24.

Average length of service is anticipated to be 4-6 months (but no longer than 24 months). Four scattered-site housing units will be available at all times, providing up to 6 beds in the Greater New Haven area, to flexibly serve individual and family households. Approximately 12 households will be served annually.

The RRH project will utilize Housing First and progressive engagement models, not requiring specific services as a condition of housing, however, all RRH participants will meet with a Case Manager at least once/month. Services will be made available by program staff & tenants will be encouraged to utilize services needed to meet their individualized goals, including: case management; health screening, prevention and education; benefits assessment and advocacy; educational and career assessment and linkages; financial literacy training; linkage to community resources; life and apartment skills assessment and training; transportation; and tenancy skill building. Participants will have leases in their own names and the same tenancy rights as others in the community. Staff works with tenants to understand lease requirements and support lease compliance.

All client data will be entered into HMIS. 83% (5 out of 6 persons served) will exit to permanent housing destinations, and will be placed into permanent housing within 30 days of program entry. 58% (5 out of 8 participating adults) will increase their total income (from all sources) as of the end of the operating year or project exit.

YC uses its DHHS and State of CT funded outreach programs to educate area youth and communities to identify and refer homeless youth who have been homeless the longest and have the most severe service needs. YC collaborates with an array of local homeless and non-profit providers to insure a full range of mainstream services and benefits are available based on individual needs, as assessed through program case management services. CoC support is needed for guidance on best practices documenting homeless history, training and technical support on Housing First, tenant rights, and to support statewide efforts to insure an effective coordinated access system and insure that the most at-risk individuals are served first, and in the optimal manner.
