### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Safe Haven Scattered Site II is a Housing First Model of PSH. The January '18 PIT had the CH number in New Haven at 80. 68 have been housed. LCS requests renewal funds for PSH for 10 single adults. LCS placed people in studio and 1 BR market apartments. The CAN is the referral point for housing thus this program relies upon the CofC. The CAN is administered through the local United Way to facilitate coordinated assessment, documentation and matching. An inter-agency bi-weekly Housing Case Conference has been in operation since July, 2014. LCS has a full time staff member dedicated to CAN entry processes. To access PSH, RRH and other supportive services, people must be screened by 2-1-1 and scheduled for a CAN assessment and intake. They are administered the VI-SPDAT.

The 10 people served by this project are CH, over 18, have trauma, mental illness and/or substance use disorders. Often, out of care or not following treatment plans, they are described as the "hardest to serve." The intensive case manager conducts routine home visits to assess the participant's functioning and conformance with lease requirements. The case manager is in constant communication with the participant, treatment providers and landlords to address and avert crises that may interfere with maintaining housing.

The performance outcome for this project is 100% of the participants will either remain in the program or exit to permanent housing. 100% of the participants will maintain or increase income from all sources.

Assisting people to maintain housing once they are placed is the key to a successful Housing First program. LCS brings robust services through a collaboration with Yale for primary health care, substance abuse treatment, mental health services and assistance with securing disability verification. The housing case manager, who provides or arranges for transportation, housing search assessment of service needs and life skills, assists project participants in applying for mainstream housing programs as openings become available for HCV and Sec 8. Service plans include strategies to increase income to expand mainstream housing options.

LCS engages in outreach to identify chronically homeless who have co-occurring conditions - HIV, serious mental illness, addiction disorders, and/or chronic illnesses. Outreach staff combs neighborhoods where high drug and sex worker activity take place, homeless shelters, soup kitchens, "hook-up" locations and the public library.

LCS collaborated on the design/implementation of the CAN and is an integral member. The Executive Director is the Co-Chair of the local CoC oversight work group. Our local CoC is comprised of 17 cities and towns with representatives from HUD and non-HUD funded organizations and other stakeholders. LCS participates as members and in leadership roles in local

CoC work groups.

The project participates in HMIS. All program staff are trained to utilize Caseworthy.
