3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Funds for this project will be used for rapid rehousing (RRH) services. DOH will be the fiduciary and New Reach will be the subcontractor. DOH will be administering this grant including reporting and New Reach will be providing case management using a Housing First model. These funds will pay for a .33FTE RRH case worker and will serve an estimated 12 family households annually. Households will be housed in scattered-site apartments in the Greater New Haven region. New Reach will serve clients exiting shelters and those living on the streets or other place not meant for human habitation and who come through the local Coordinated Access Network (CAN). New Reach has a solid infrastructure in place for RRH services. With these funds, New Reach anticipates being able to provide rental assistance and support services to 12 households over the period of the grant year. The target population is families with dependent children. Housing will be scattered site in the Greater New Haven area. All program data will be entered through HMIS. New Reach is actively participating in the local CAN system for both individuals and families.

There is a critical need for rapid rehousing services in the Greater New Haven region. As of August 2018, there were 320 families on Greater New Haven family registry. Of these 320 families, 200 (63%) scored in the Rapid Rehousing range of the VI-SPDAT. Our current regional rapid rehousing program (state funded) is consistently at capacity and often times has a waiting list.

Support from our CoC (CT Balance of State) is critical to the success of this project. New Reach is an active participant in CoC meetings where we gain valuable guidance from the consultant as well as others in the field on best practices as well as further opportunities for collaboration. Further, we are able to report back to the CoC on what is and what is not working for our projects. These efforts help the CoC to get a regional perspective on the needs of homeless populations in the area and determine where resources are needed most.

For this project, each client will receive case management which will include a thorough assessment of each client's needs and strengths. Case management is provided using a person-centered planning approach, with an assessment of individual strengths and barriers when creating client goals and objectives. Referrals to community providers and to state benefits will be given on an as needed basis. These needs may include; childcare, education, employment, food, legal, mental or medical health, and substance abuse. It is anticipated that 86% of participating clients will remain in permanent housing at the end of the year. 
