CCEH was the organizing entity for the creation of HMIS in CT and has been HMIS lead for 7+ years. CCEH is a robust organization with a complete management structure that uses internal/external coordination strategies to successfully manage over \$1M in HMIS funds annually. CCEH has achieved: conversion of multiple HMIS platforms to a single, statewide, multi-CoC HMIS, timely draw downs in LOCCS/submission of APRs, & a consistent track record of resolving end user HMIS issues, & providing innovation to the CAN processes as they evolve.

There is a critical community need for HMIS for us to identify, prioritize & serve CH persons & all CH households. CT & this project follows HUD Notice CPD-14-012 to prioritize serving CH persons w/ the longest history of homelessness & most severe service needs in the order indicated. HMIS data is a critical component to our effectiveness & most efficient & fair use of limited housing resources. The project will provide HMIS Services to the Greater Hartford area, which represents nearly 1/4 of the homeless serving projects in the state.

CT HMIS is a dynamic, statewide implementation of HMIS. It has over 1,400 unique active users with over 200 organizations with almost 2,000 projects that includes the fully integrated Coordinated Entry system. CT uses 211 for our front door to our Coordinated Entry system, & all 211 housing specialists are licensed CT HMIS users.

The project will rely on HUD funds to support activities that cannot be funded through mainstream sources; HUD CoC funds are needed to make this project possible, to help end track our progress in ending family and youth homelessness.

Additional projected outcomes:

- Attend CoC meetings, review & continuously work with partners to improve data quality;
- Convene regular meetings in the CoC to review & create solutions to community HMIS needs;
- Staff the HMIS HelpDesk & website to bring user support to the community;
- Provide training & on-site support for HMIS users;-Complete timely AHAR submission;
- Provide data reports to CoC as needed to monitor community outcomes;
- Conduct regular site visits to HMIS programs to ensure compliance with HUD

data standards;

-Work with the CoC to address community needs with HMIS data, system design and functionality;

-Regularly provide demographic data to CoC to monitor progress in serving homeless households;
