3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Pendleton House Permanent Supportive Housing Project will provide reduced rent, based on individual income & supportive services to 12 chronically homeless single adults with a serious mental illness and/ or substance abuse disorders. Supportive services (e.g., case management, life skills training, benefits advocacy, employment, mental health & addiction services, & tenancy skill building) will be provided by project staff. The project will provide congregate housing services in New Haven, CT and will collaborate with the Greater New Haven Coordinated Access Network, Department of Mental Health & Addiction Services, Department of Social Services, Social Security Administration, Yale New Haven Hospital, and various local non-profits to provide an array of mainstream services based on each tenant’s individual needs, which are identified through case management & a semi-annual assessment. The Pendleton House is a duplex style home, with three 2 bedroom apartments on each side, for a total of 6 apartments and 12 beds. Each apartment has two single bedrooms, shared bathroom, kitchen, and living space. The project will obtain referrals from the local Coordinated Access Network & participate in outreach efforts to identify people who have been homeless the longest & have the most severe service needs. The project will use a Housing First model & offer immediate access to housing without prerequisites. Participants will have leases in their own name & the same tenancy rights as others in the community. Property Management will review lease requirements with each participant at the time of lease signing & as needed to support lease compliance. Services will be designed to assist tenants in meeting lease obligations & increasing income. Staff will be in frequent contact with tenants to avoid & address lease violations. Project outcomes will include: a) 85% of tenants will remain in PSH or exit to PH as of year-end b) 50% of adults will increase their income. The project is supported by the CoC because it addresses the community’s need for Chronically Homeless designated beds & specialized services for people with serious mental illness and/ or substance abuse disorders and is an essential part of the CoCs strategy to end homelessness among those who have been homeless the longest and have the most intensive needs. The project will leverage mainstream resources to maximize client income & provide a full array of services & rely on CoC funding to support activities that cannot be funded through other sources. The project will upload data to HMIS as required

- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid withholding on your share of partnership income.


