 - Point-in-time Count of Homeless Persons (PIT) is scheduled for 1/21/20
 - It was noted that some PIT volunteers had signed-up on line to volunteer but had not heard back from the Regional Coordinators (RC).
 - Some noted that because there had been changes to how RC received information on volunteers, there was confusion around how to access the volunteer information.

- Providers can complete score change request forms - due 1/31/20
- HI rescoring and distributes final reports in March
- Providers have the ability to grieve scores in early April
- SC adopts Corrective Action threshold in April

Background on CT BOS

The CT BOS CoC is responsible for overseeing over \$41 million in annual funding from the Department of Housing and Urban Development (HUD) for over 100 projects serving homeless people. CT BOS is comprised of representatives from organizations that fund or provide services to homeless people or otherwise represent the interests of the people who have experienced homelessness. The following localities throughout the state participate in the CoC: Hartford, Litchfield, New Haven, New London, Windham, Tolland, Middlesex counties.
