# 2020 CoC Competition

---

- Congressional action necessary to authorize non-competitive process – HUD SNAPS office thinks it will happen, not necessarily tied to COVID relief
- Very basic auto-renewal process for existing CoC projects
- No new projects, and no new funding except for FMR adjustments to existing projects
- TBD if reallocation will be an option



# 2021 Point in Time (PIT) Homeless Count

---

- Highly likely that sheltered count will be required
- HUD looking for options to balance need for data on unsheltered homelessness with safety/logistical challenges
- HUD is seeking alternatives (CoCs have suggested using By Name List info/HMIS)
- HUD indicated release of additional information in late September.





# Reminder - CDC Eviction Moratorium



- Temporary Halt in Residential Evictions to Prevent the Further Spread of COVID-19
- Halts residential evictions for non-payment of rent, fees, penalties & interest for any covered person until 12/31/20
- After 12/31/2020, housing provider may require payment in full & failure to pay may make tenants subject to eviction
- **To be covered each adult must provide landlord with a declaration** affirming that they meet eligibility requirements

# Monitoring Selection Criteria

---

## Primary Selection Criteria:

- Prioritize visits postponed in 2020 due to COVID-19
- Prioritize agencies with poor performance on a previous monitoring visit
- Prioritize larger grants and agencies with combined large awards
- Prioritize agencies that have not had CoC projects previously monitored by CT BOS or DMHAS
- Prioritize agencies that are new CT BOS CoC grant recipients or subrecipients

# 2021 Renewal Evaluation Process

---



- 2021 Paper Consumer Surveys distributed in June
- Consumer survey links, Evaluation Timeline and instructions distributed to providers in October
- Providers update APR data used for preliminary scoring in November
- Providers receive evaluation reports December
- Providers can make data changes and complete Score Change Form (if applicable) in January
- HI rescores and distributes revised reports in March
- Providers have the ability to grieve scores in April



# 2021 Renewal Evaluation Process

---

Question: Can older adults and people on SSI/DI can be removed from the set when evaluating employment income?

Answer: APRs do not provide the information that would be required to do this.
