HUD Updates



BOS Participation in Reaching Home Campaign Advocacy Strategies group



CLARIFICATION



- In 2021 competition, projects may increase their HUD CoC project administrative budget lines to 7% without a grant agreement amendment.
- Total project costs must remain the same projects must move funds from another Budget Line Item (BLI).
- For Rental Assistance (RA), you may not reduce the unit number or size.
- Amount of funds moved cannot exceed 10% of the approved BLI you are moving money out of.
 - Example: If there is a Services BLI of \$30K, you may move up to \$3K from that line.
- These changes require a grant agreement amendment:
 - Adding a new Project Admin BLI in a project that doesn't already have one
 - Shifting funds in excess of the amount cited above

CoC NOFO - What's New?


- Housing First and LGBTQ anti-discrimination are back!
- Increased emphasis on:
 - Race Equity: Actions to identify and address equity barriers; including organizations serving culturally specific communities in CoC; and using equity factors in project review/ranking
 - Inclusion in CoC planning of People with Lived Experience of Homelessness
 - Coordination with PHAs and Health Care
 - Integration of Tribes and Tribally Designated Housing Entities (TDHE's)
- New CoC application scoring factors:
 - Addressing COVID-19
 - Coordinating with ESG around CARES Act funding

CoC NOFO - What's New? (2)

- Eliminated or Deemphasized
 - Unsheltered count data (not scored)
 - Systems Performance Measures (points reduced)
- Tier 1 is equal to 100% of Annual Renewal Demand
- YHDP
 - Renewed non-competitively
 - Cannot be reallocated
 - Replacement Projects relevant information to be covered in project application training



Domestic Violence (DV) Bonus -Overview

- Up to \$2,437,042 available for CT BOS
- Participant eligibility: HUD Homeless Definition Category 4 (fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, human trafficking)
- Eligible Project Types
 - Rapid Re-Housing (RRH)
 - Joint Transitional Housing/Rapid Re-Housing (TH/RHH)
 - Supportive Services Only for Coordinated Entry (SSO-CE)
- Minimum project size: \$50K
- Expansions allowable can expand renewals funded via DV Bonus or Regular CoC funds (existing renewal need not be dedicated to DV)



DV Bonus - Scoring

RRH and Joint TH/RRH:

- Up to 25 points CoC score
- Up to 25 points quantified need for the project, extent of the need, and how the project will fill the gap
- Up to 50 points -previous performance of the applicant & applicant ability to house survivors and meet safety outcomes

For SSO CE

- Up to 50 points CoC score
- Up to 50 points demonstrated need for a CE system that better meets the needs of DV survivors and how the project will fill this need.
