- Renewal Evaluation Score is final
- Deadline to file a Grievance

CT BOS New Project Request for Proposals (RFP) due 6/6/22



BOS is accepting new project applications for the 2022 competition for CoC Bonus/Reallocation and for DV Bonus

Program Models:

- Rapid Rehousing (RRH);
- RRH for Category 4 Survivors of Domestic Violence (to be submitted thru HUD DV bonus application);
- Services in existing Permanent Supportive Housing (PSH) programs that don't have designated funding for services from any public source (e.g., HUD or DMHAS);
- Services in Tax Credit/DOH Bond Financed/HOME ARPA congregate PSH programs scheduled to open within HUD's required timeline and not yet fully funded.



CT BOS New Project Request for Proposals (RFP) due 6/6/22 (2)

- Information on HUD CoC funding will not be fully available until the Notice of Funding Opportunity (NOFO) is released.
- In 2021 competition, only \$20 million was available nationally for Tier II projects.
- CT BOS received a high CoC application score and received very little funding in Tier II.
- Applications are submitted through Zengine (CT BOS database)

- CT Coalition Against Domestic Violence (CCADV) requested to Reallocate/Transition an existing project from DV Bonus RRH to PSH
